I agree that the term of the original Agreement is for 12 months and then renews according to the terms of the Agreement. This pre-authorized payment agreement will automatically renew annually and will remain in effect until cancelled in writing by either party. I agree that if this preauthorized payment agreement terminates for any reason before the end of the original 12-month period, or during a renewal term, Zinnia is authorized to debit my account for the full remaining balance of the remaining term due unless other arrangements for payment of the balance have been approved by Zinnia. As a convenience to me, I hereby request the credit card issuer above to accept and honor transfer withdrawals from my account. I agree that your rights in respect to each transfer shall be the same as if it were drawn personally by me and that you shall be fully protected in honoring such transfer. I further agree that if any such withdrawal is dishonored, whether with or without cause and whether intentionally or inadvertently, the credit card issuer shall be under no liability whatsoever if such dishonor results in the forfeiture of benefits. These Authorizations shall remain in effect until revoked in writing, mailed to the other parties at the address of record. The Company or Financial Institution shall have a reasonable time to act on the revocation notice. I have retained a copy of these Authorizations.
